

**MANVILLE WATER SUPPLY CORPORATION  
 LOST PINES GROUNDWATER CONSERVATION DISTRICT  
 APPLICATION FOR OPERATING PERMIT  
 PROPOSED BLUE WELL #9  
 SUPPLEMENTAL INFORMATION**

1. Distance between Proposed Well #9, Proposed Well #8, and registered wells on neighboring properties - with known well depths and estimates for the aquifer each well is completed based on available data.

Distance between Proposed Blue Well #9 and Proposed Blue Well #8 is 1,630 ft.

Distance between Proposed Blue Well #9 and existing Blue Wells #1 and #2 located on the adjacent 150 Acre Wellfield is 1,960 ft. Blue Well #1 and #2 are only 200 ft. apart. Both appear to be in the Simsboro Formation with "vertical separation barrier". (Tested)

Distance between Proposed Blue Well #9 and Wells #3 and #4 is 3,150 ft. (only 200 ft. between Wells #3 and #4).

Distance between Proposed Blue Well #9 and Wells #5 and #6 is 4,840 ft. (only 200 ft. between Wells #5 and #6).

Distance between Proposed Blue Well #9 and Blue Well #7 is 1,500 ft.

The six permitted Manville Wells located on the 150 Acre Blue Wellfield were permitted between 2000 and 2009 as follows:

- Well #1 - Depth 650'-810' - 1,000 gpm
- Well #2 - Depth 500'-605' - 1,000 gpm
- Well #3 - Depth 755'-855' - 1,000 gpm
- Well #4 - Depth 440'-650' - 1,000 gpm
- Well #5 - Depth 790'-890' - 1,000 gpm
- Well #6 - Depth 455'-650' - 1,000 gpm
- Well #7 - Depth 440'-550' - Standby to Wells #1 thru #6

The existing Manville Wells completed in the upper Simsboro Sand (Wells #2, 4 & 6) have been producing millions of gallons per month for the last 12 years. (Not aware of any complaints from Domestic Well Owners)

Distance between Proposed Blue Well #9 and identified registered wells on neighboring properties with well depths and aquifer.
